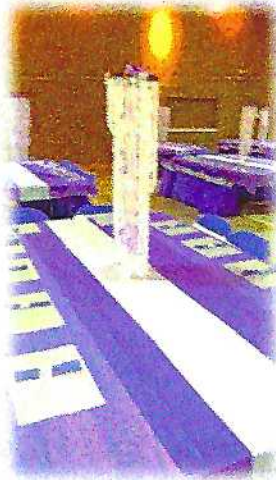

HALL INCLUDED: Hall and lounge rental include chair and table set up/breakdown as well as sweeping mopping and removal of trash. Paper table covering can be supplied with our catering. **Any changes made after the floor plan is approved will result in a \$50.00 charge per change.**

FOOD: All food left over is the property of the **Customer** and must be removed from the premises before the closing of the event. Bring pan for all left over food approximately 11 ½ x 19 ½ x 3 ½. If Z.B. Falcons provides pan's a charge of \$5.00 per pan will apply. When Customer supplies own catering pan must be brought with Customer. At no time will there be access to Z.B. Falcons kitchen facility. All left over food must be discarded in dumpster not trash can inside building provided by Z.B. Falcons.

SECURITY: One (1) security guard is mandatory for every 100 guests at \$25 hour per guard. Security is paid one hour after function ends during clean up to secure the property once all customers and guest has vacated the property. The Z.B. Falcon member in charge for the evening and any officer has the right to escort anyone from the event.

DEPOSIT: A minimum of \$250.00 deposit with a personal check, money order or cash is required at the time of the rental of the hall. In the event of a cancellation, all money will be refunded before (Date) _____. In the event damage(s) occur, the deposit is forfeited or deducted from deposit. If cancellation with rebooking occurs, deposit will be \$350.00 non-refundable. **DEPOSIT WILL BE REFUNDED WITHIN 7 BUSINESS DAYS FOLLOWING THE EVENT DATE LESS ANY DAMAGES ADDITIONAL CHARGES OR CLEANING. PICK-UP OR MAIL, IF MAILED MAY TAKE UP TO 10 DAYS. RETRUNED CHECKS (NSF) ARE SUBJECT TO A \$25.00 CHARGE, A NEW DEPOSIT BROUGHT IN CASH TO SECURE THE REQUESTED DATE. DEPOSIT WILL NOT BE REFUNDED IF ANY VIOLATION OF THE CONTRACT OCCURS.** Deposit of \$100 for any candy bar display is required in addition to the regular deposit.

BAR: Only Z.B. Falcons Bartenders Are Allowed Behind The Bar As Stated By Indiana Law. No Liquor and/or Beverages Are Allowed To Be Brought Into Any Event! Bartenders Reserve The Right To Refuse To Serve Customer Or Guests.

Rules

1. **Alcoholic and/or non-alcoholic beverages are strictly prohibited from being brought on and into the premises of Z.B. Falcons, Nest 80.** Any alcoholic and/or non-alcoholic beverages found on or in the premises of Z.B. Falcons, Nest 80 will be properly disposed of. If this conduct continues, the guest or guests of the Customer will be asked to leave the premises of Z. B. Falcons, Nest 80. This also a violation of contact and can result in forfeiting the deposit. **ANYONE CAUGHT WILL BE REMOVED FROM THE EVENT AND DEPOSIT WILL BE FOREFEITED.**
2. Open containers of alcoholic and/or non-alcoholic beverages are strictly prohibited to be carried from inside the facility to the outside premises of Z. B. Falcons, Nest 80. If this conduct continues, the Customer or guests of the Customer will be asked to leave the premises of Z.B. Falcons, Nest 80
3. Decorations are strictly prohibited from being taped, glued, nailed, stapled and/or adhered in any form or fashion to the walls of Z.B. Falcons, Nest 80. Decorations may be affixed to the walls by using the permanent hooks on the walls provided by Z.B. Falcons, Nest 80. Excessive clean up can result in charge or forfeit of deposit.
4. The use of staples, nails, and tape on the floor, walls, chairs and tables is strictly prohibited. If any of the aforementioned is done, the Customer will be fined one hundred dollars (\$100.00).
5. Votive, candles with covers or floating candles are allowed. Due to fire hazard, no open candles are allowed.
6. The use of confetti or glitter is strictly prohibited. If confetti or glitter is used, the Customer will be fined one hundred dollars (\$100.00). To be deducted from deposit.
7. Balloons must be securely anchored. The exception is when a vendor is hired to do decorations. NOTE vendor or customer must clean up any balloon debris.
8. Any damages by the Customer or guests of the Customer, to the inside facility or outside premises of Z. B. Falcons, Nest 80 will be the responsibility of Customer. Cost of damages will be deducted from deposit.
9. For the safety of Z. B. Falcons, Nest 80 and the safety of Customer and guests, all functions will have at least perimeter lights on. At no time will the lights be turned off completely.
10. Arrangements for entertainment or music are the responsibility of the Customer. Additional electrical adaptations are strictly prohibited.
11. Wedding cake or desserts – Customer responsible for plates, knife, napkins & forks.
12. Bartenders reserve the right to refuse to serve Customer or guests.
13. Clean up must be completed the night of the event by one hour following the event. If not cleaned up can result in an extra charge or deposit forfeited.
14. Z.B. Falcon, Nest 80 will open door 15 min. before event at _____. Entertainment will play last song and Bar will close at _____ one hour before clean up time. Premises will be vacated no later than _____.
